National Wireless Safety Alliance Announces Board of Governors Appointments

Brewer, Brown and Roshek Join NWSA Board of Governors

Other assessment and certification programs NWSA will likely unveil in the future include Rigging, Small Cell/DAS Technician, Structural Modifications, Gin Pole Operations and Broadcast Tall Tower Technician.

Neal Brown

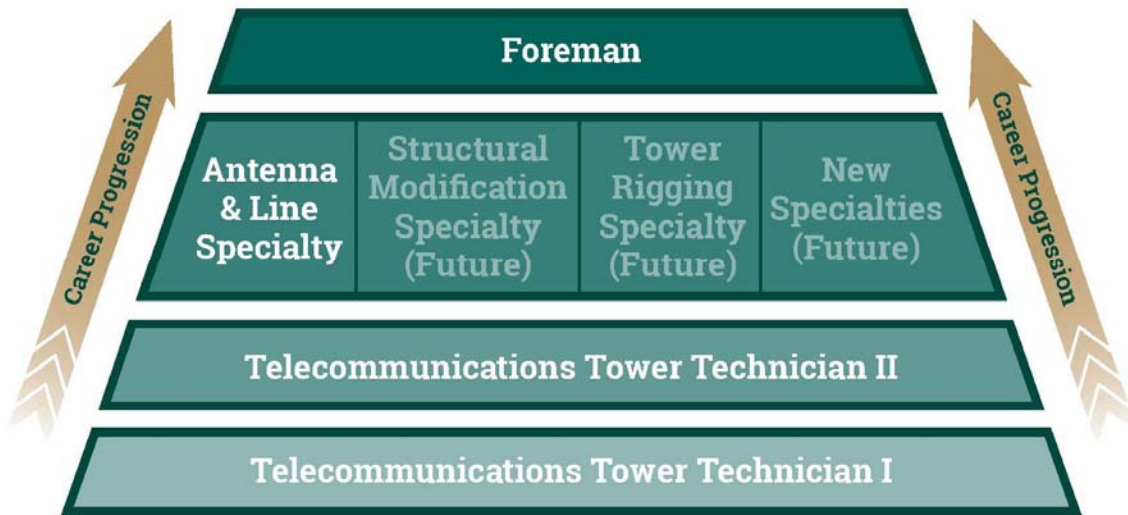
